

4-H and FFA Exhibitor Trailer Space Application

Santa Clara County Fair

RV Area – all spaces are anticipated to have water. No electrical hookup will be available, generators are allowed. Waste water must be self-contained. Pumping services will be available, at an additional charge payable to the company pumping the RVs. The Fairgrounds is not responsible for any problems or damages caused by pumping of waste water.

RV area is east of the Livestock area and will allow one vehicle to park next to RV.

Access to fairgrounds will require a parking pass. Each Trailer Space will get a pass for the trailer and one pass for a vehicle.

Rules & Guidelines:

- Spaces will be assigned after Entry Due Date. Late Applications will be accepted on a Space Available basis. Spaces are available only to Livestock and Small Animal Exhibitors and their Chaperones, Leaders, and Advisors.
- 4-H & FFA Trailer Spaces will be assigned by the Club or Chapter. Families with children in both 4-H & FFA can only apply under one organization.
- 4-H County Large Animal Leaders and FFA Advisors (1 per Chapter) are eligible for RV spaces. This space can only be used by the individual – can not be given to another person in Club or Chapter.
- **Trailer spaces will be allotted on the following basis:**
 1. Distance from the Fairgrounds.
 2. Number of livestock exhibitors and exhibits. Type of livestock exhibited.
 3. Total number of exhibitors to be supervised.
- After trailer assignments are made, passes may be picked up at the **Livestock office** beginning on August 2, 2010.
- Trailers will not be allowed to park without a permit from the **Fair Office.**
- Once trailer assignments are made, the application fee is non-refundable (except when space is not granted).
- Trailers may not be parked early without the permission of the Fair Office.
- Trailer area must be quiet from 11:00pm – 7:00am (no parties, no generators, etc.)
- No tents – Tent trailers are allowed.
- **All Junior Department Exhibitors or any Open Exhibitor under age 18, staying in the RV area, must be chaperoned by an Adult (Age 25 or older). The Chaperone must sleep in the trailer with the Junior Exhibitor(s) – one Chaperone cannot chaperone two trailers. Any trailer found to be without acceptable supervision, as determined by the RV Area Manager/Livestock office will be required to be removed immediately from the County Fairgrounds. If owner of the RV/Trailer is not able to be located, the RV/Trailer will be removed at owner's expense.**
- Trailers may be parked after 6:00 am on the date reserved. Trailers/RVs left in place beyond reservation date will be towed at the owner's expense. It is expected that Trailers/RVs will be removed by 10:00pm on the last day of reservation.
- Failure to abide by the rules can result in immediate removal of trailer/RV from Fairgrounds.
