### HOLD HARMLESS/RELEASE AGREEMENT LIVESTOCK SALE

**Please read carefully and sign:** (Livestock will not be sold if not signed, by exhibitor **AND** parent)

In consideration of the Santa Clara County Fairgrounds Management Corporation hereinafter: "SCCFMC", allowing \_\_\_\_\_ hereinafter referred to as "owner", to participate in the Junior Livestock animal auction and sell owners animal(s), it is agreed that:

1. All animals entered into the auction will be sold for processing. There will be **NO LIVE ANIMAL SALES** at the auction. Small animal processing and delivery is the responsibility of the seller.
2. **DRUG STATEMENT PURSUANT TO 21 USC SECTION 33 (C) (2):**
  - a) Owner acknowledges that Federal Food, Drug and Cosmetic Act prohibits the introduction or delivery into interstate commerce of any food that is adulterated or misbranded. Adulteration includes poisonous or deleterious substances, and new animal drugs defined as unsafe within the meaning of Section 512 (21 USC Section 260b) of that act and those drugs listed in Section 402 (21 USC Section 342).
  - b) Owner states and certifies that the animals placed in the Junior Livestock animal auction are free of adulteration, including drug residue and can be sold for human consumption, within the meaning of the Federal Food, Drug, and Cosmetic Act, as amended.
3. **INDEMNITY:**

The owner agrees, for him/herself and his/hers heirs, executors, administrator, or assigns to indemnify and hold harmless the SCCFMC, its directors, officers, agents, and employees from any and all losses, claims, actions or proceedings of any kind may be initiated by purchasers, handlers or consumers of owner's animal(s) and/or any other person or organization: including reimbursement for all legal costs and attorney fees incurred by the indemnified parties or any of them, for the defense of any actions which may hereafter directly or indirectly from the sale, handling and human consumption or owner's animal(s).
