# Official Show Rules

1. Show will be governed by the latest revised rules of the ARBA. Your entry indicates your acceptance of these rules.
2. No entries accepted from anyone within a 50 mile radius of an active Domestic RHD outbreak or 25 miles of an active Wild/Feral RHD outbreak. Any unhealthy rabbits or cavies must be removed promptly from the showroom.
3. All rabbits must be permanently and legibly marked in the left ear. All cavies must be permanently tagged or tattooed in the left ear.
4. Once entry is made the Entry Fee is Due! Even if you are unable to attend, the funds need to be paid. Failure to pay the fees will result in you being banned from SCCRCS shows until balance is paid. Late fees may be applied if an extended period of time passes.
5. Mailed entries must be postmarked by September 18, 2024. Emailed entries are due by September 23, 2024 by midnight.
6. Emailed changes to confirmations accepted until 6pm on September 25, 2024.
7. Awards must be picked up at the show. They will NOT be mailed. Legs or exhibitor reports will be mailed within 30 days of the show.
8. All exhibitors are responsible for getting their animals to and from the judging table in a timely manner. There will be no recalling of classes for missed animals. Judging for shows may run concurrently and will not necessarily follow each other.
9. Please be considerate when setting up your space as we need room for all rabbits and exhibitors. Exhibitors must clean their area when leaving; otherwise a fee may be imposed.
10. All animals are entered at the owner's risk. Every precaution will be taken to safeguard and minimize hazard, losses, and mistakes, but show personnel, judges, and the Santa Clara County Fairgrounds Management Corporation are in no way responsible for the death or injury of any animal.
11. Parents are responsible for the conduct of their children. Parents are required to pay for any damages caused by their children. Such behavior may result in suspension from showing in SCCFMC shows by the youth or parent.
12. The show chairman reserves the right to assign, reassign, add, or substitute judges as necessary.
13. Any and all questions or issues arising that cannot be resolved by these rules shall be decided by the show committee, and superintendent, whose decision will be final and all parties shall abide by these decisions.

# ATTENTION EXHIBITORS

1. Moving an animal to another class without secretary approval will result in disqualification of the animal.
2. Ear number changes are the only allowed changes.
3. You will receive an email confirmation of your entry. You may make changes via email.
4. Confirmations are sent within 24 hours of the email entry deadline.
5. IT IS YOUR RESPONSIBILITY TO CHECK YOUR CONFIRMATION FOR ERRORS
6. Final changes or corrections must be made within 24 hours after the email deadline via email or phone.
7. Included with your entry: NO ATTACHMENTS! Exhibitor name, address, city, state, zip code, phone number, and email address. Entering OPEN or YOUTH, breed, variety, sex, class, of rabbit and ear number.
