ATTENTION EXHIBITORS

1. Ear number changes are the only allowed changes.
2. Moving an animal to another class without secretary approval will result in disqualification of the animal.
3. You will receive an email confirmation of your entry.
4. IT IS YOUR RESPONSIBILITY TO CHECK YOUR CONFIRMATION FOR ERRORS
5. Ear changes maybe made by email by May 27 or at the table before judging.
6. Included with your entry: NO ATTACHMENTS! Exhibitor name, address, city, state, zip code, phone number, and email address. Entering OPEN or YOUTH, breed, variety, sex, class, of rabbit and ear number.



OFFICIAL SHOW RULES

1. Show will be governed by the latest revised rules of the ARBA. Your entry indicates your acceptance of these rules.
2. All rabbits must be permanently and legibly marked in the left ear.
3. Once entry is made the Entry Fee is Due! Even if you are unable to attend, the funds need to be paid. Failure to pay the fees will result in you being banned from SCCRCS shows until balance is paid. Late fees may be applied if an extended period of time passes.
4. Mailed entries must be postmarked by May 20, 2026. Emailed entries are due by May 25, 2026 by midnight.
5. Emailed changes to confirmations accepted until 6pm on March 27, 2026.
6. Awards must be picked up at the show. They will NOT be mailed. Legs or exhibitor reports will be mailed within 30 days of the show.
7. All exhibitors are responsible for getting their animals to and from the judging table in a timely manner. There will be no recalling of classes for missed animals. Judging for shows may run concurrently and will not necessarily follow each other.
8. Please be considerate when setting up your space as we need room for all rabbits and exhibitors. Exhibitors must clean their area when leaving; otherwise a fee may be imposed.
9. All animals are entered at the owner's risk. Every precaution will be taken to safeguard and minimize hazard, losses, and mistakes, but show personnel, judges, and the Santa Clara County Fairgrounds Management Corporation are in no way responsible for the death or injury of any animal.
10. Parents are responsible for the conduct of their children. Parents are required to pay for any damages caused by their children. Such behavior may result in suspension from showing in SCCRCS shows by the youth or parent.
11. The show chairman reserves the right to assign, reassign, add, or substitute judges as necessary.
12. Any and all questions or issues arising that cannot be resolved by these rules shall be decided by the show committee, and superintendent, whose decision will be final and all parties shall abide by these decisions.



JUDGING SCHEDULE

SATURDAY: BUILDING OPENS @ 7AM then JUDGING BEGINS @ 8:30 AM

Judging assignments are not made until the day of the show. A judging schedule will be posted at each judges table. Each exhibitor is responsible to carry his or her rabbits to the judging table at the proper time. Posted schedules are subject to change. Be sure to watch carefully so that you do not miss your class. Entry fees are non-refundable and classes cannot be judged over.
